EXHIBIT A

TRACT 1: A certain tract or parcel of land situate in said Amherst and bounded and described as follows:

Beginning at a point which is the Southeast corner of land now or formerly of one Johnson; thence Easterly on land now or formerly of said Johnson Seven and Four tenths (7.4) feet to a highway bound marking the corner of Hallock Street and North Prospect Street; thence Southerly on the west side of the highway Five and One tenth (5.1) feet to an iron pin on the north side of a proposed walk that is to be six feet wide; thence Westerly on the North side of said walk Sixty-two and Four tenths (62.4) feet to an iron pin; thence Northerly to a iron pin on the South side of a proposed street Seventy-four (74) feet; thence Easterly on the South side of said street Fifty-five (55) feet to the Northwest corner of land now or formerly of said Johnson to the point of beginning.

Together with such rights as are set forth in deed from William A. Reed et ux. to Horace A. Thayer et ux., dated May 2, 1911 recorded with Hampshire County Registry of Deeds in Book 667, Page 121.

TRACT 2: A certain parcel of land situate in said Amherst, and bounded and described as follows:

Commencing at an iron pin on North Prospect Street, said iron pin being the Northeast corner of land now or formerly of Rufus W. Stratton; thence Westerly on land now or formerly of said Rufus W. Stratton Two Hundred and Twenty-six and Eight tenths (226.8) feet to an iron pin on land now or formerly of Ira Boynton; thence Northerly on land now or formerly of said Boynton Eighty (80) feet to an iron pin on a new street called Pease Avenue; thence Easterly on said Pease Avenue One Hundred Sixty-three (163) feet to an iron pin on land now or formerly of Horace A. Thayer et ux.; thence Southerly on land now or formerly of said Thayer Seventy-six (76) feet to an iron pin; thence Easterly on land now or formerly of said Thayer to North Prospect Street; thence Southerly on said North Prospect Street Six (6) feet to the point of beginning.
