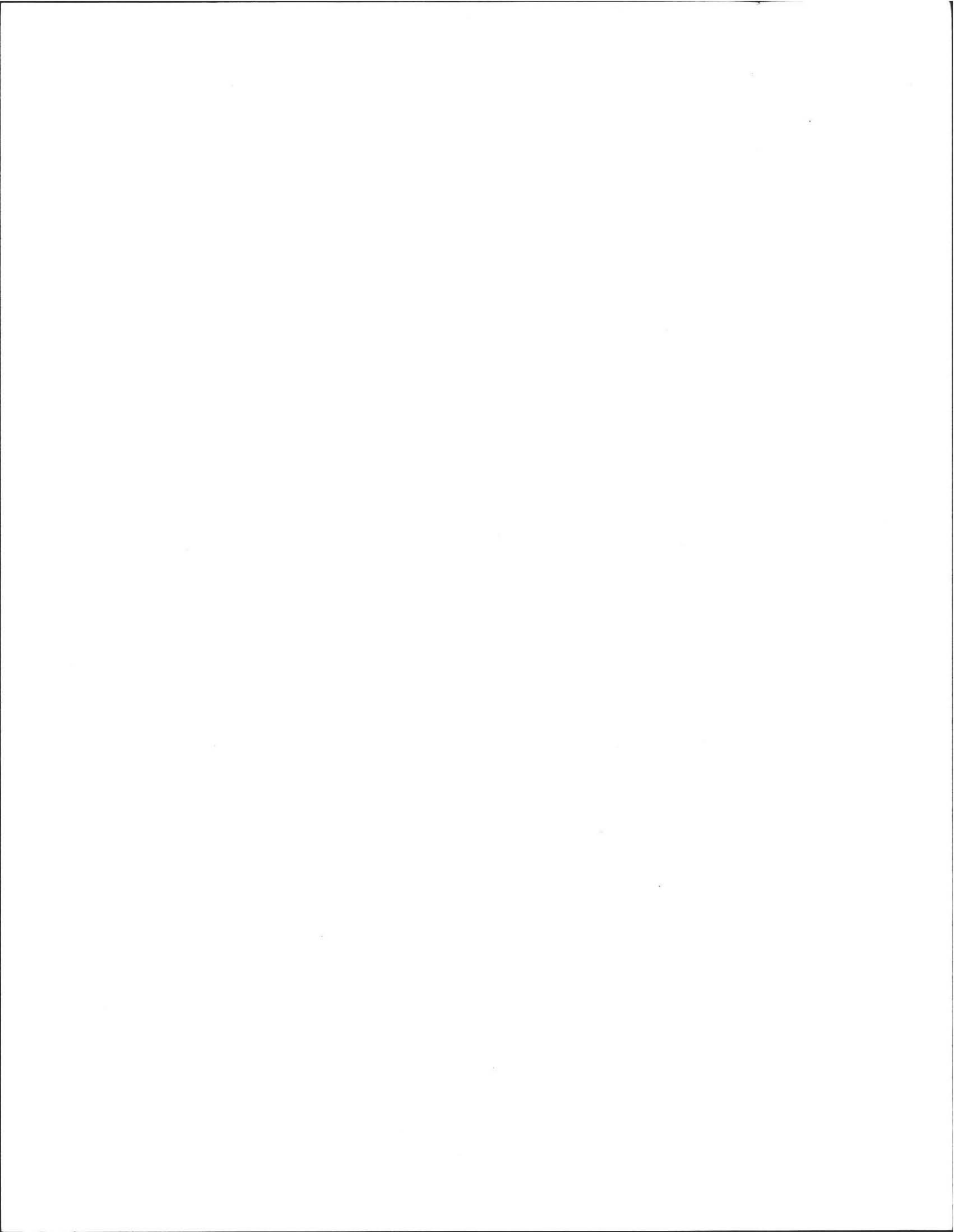
Section 7, Chapter 143, of the General Laws requires that all rubbish of demolition be removed and the area be filled in and graded subject to the approval of the Building Commissioner.

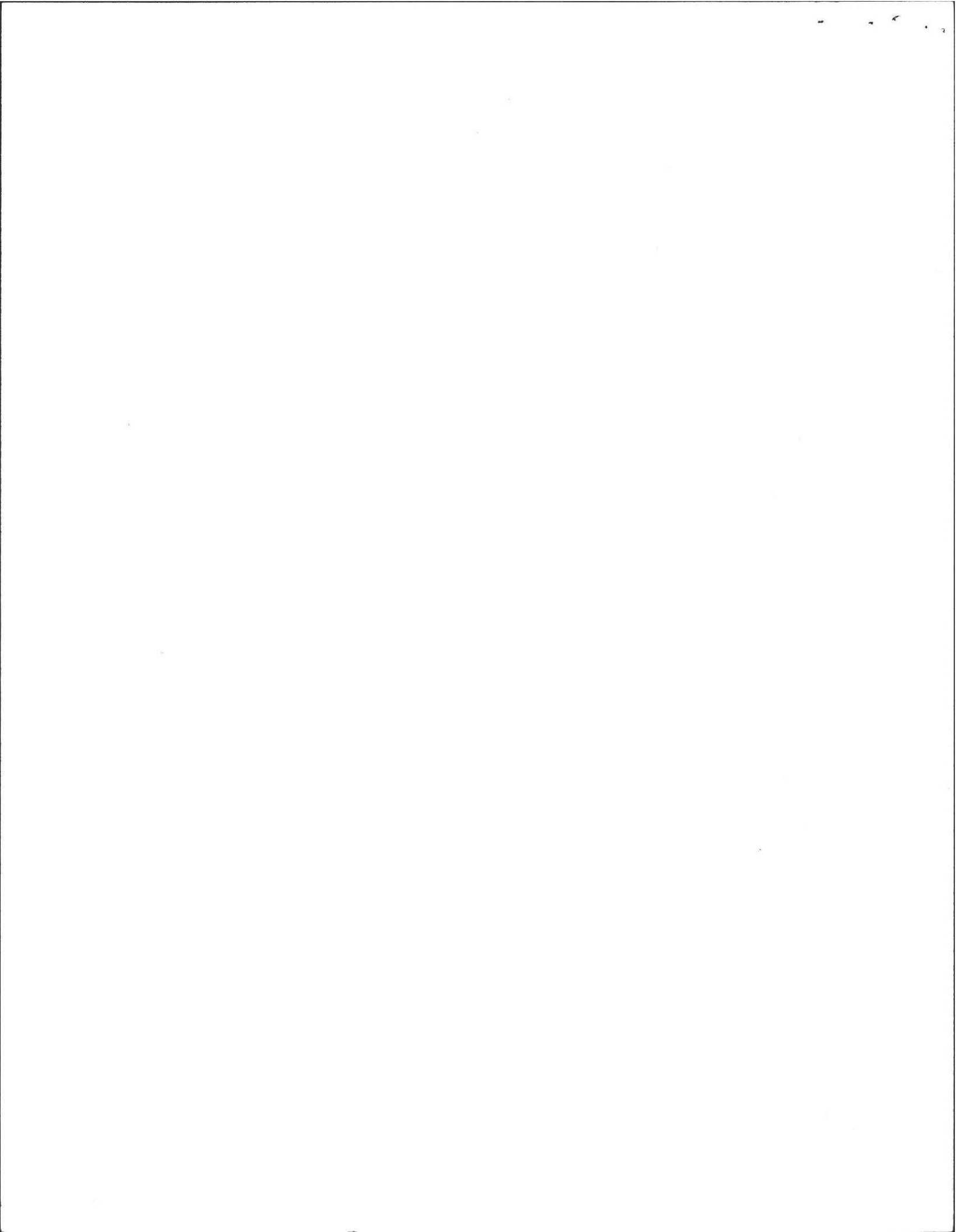

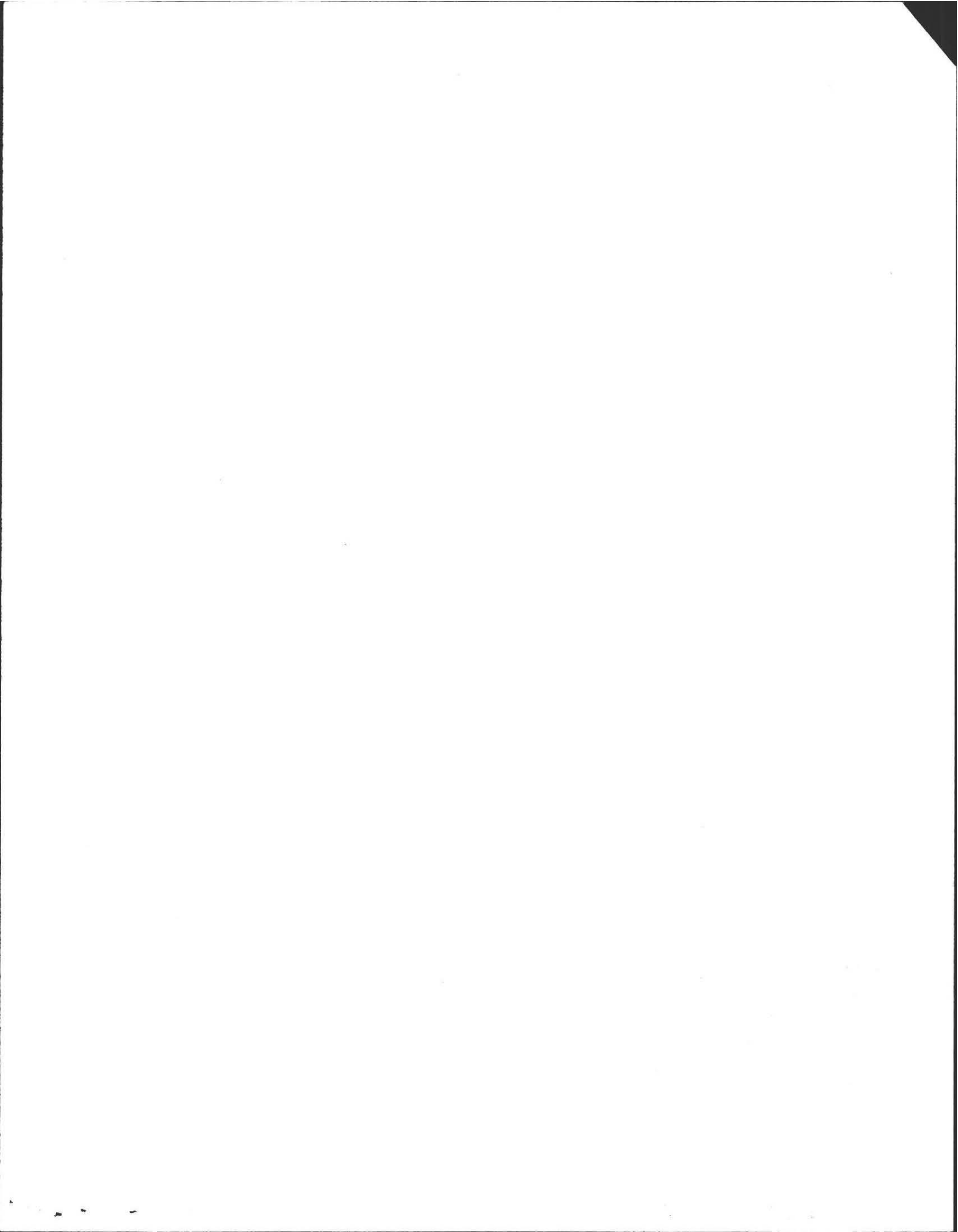
