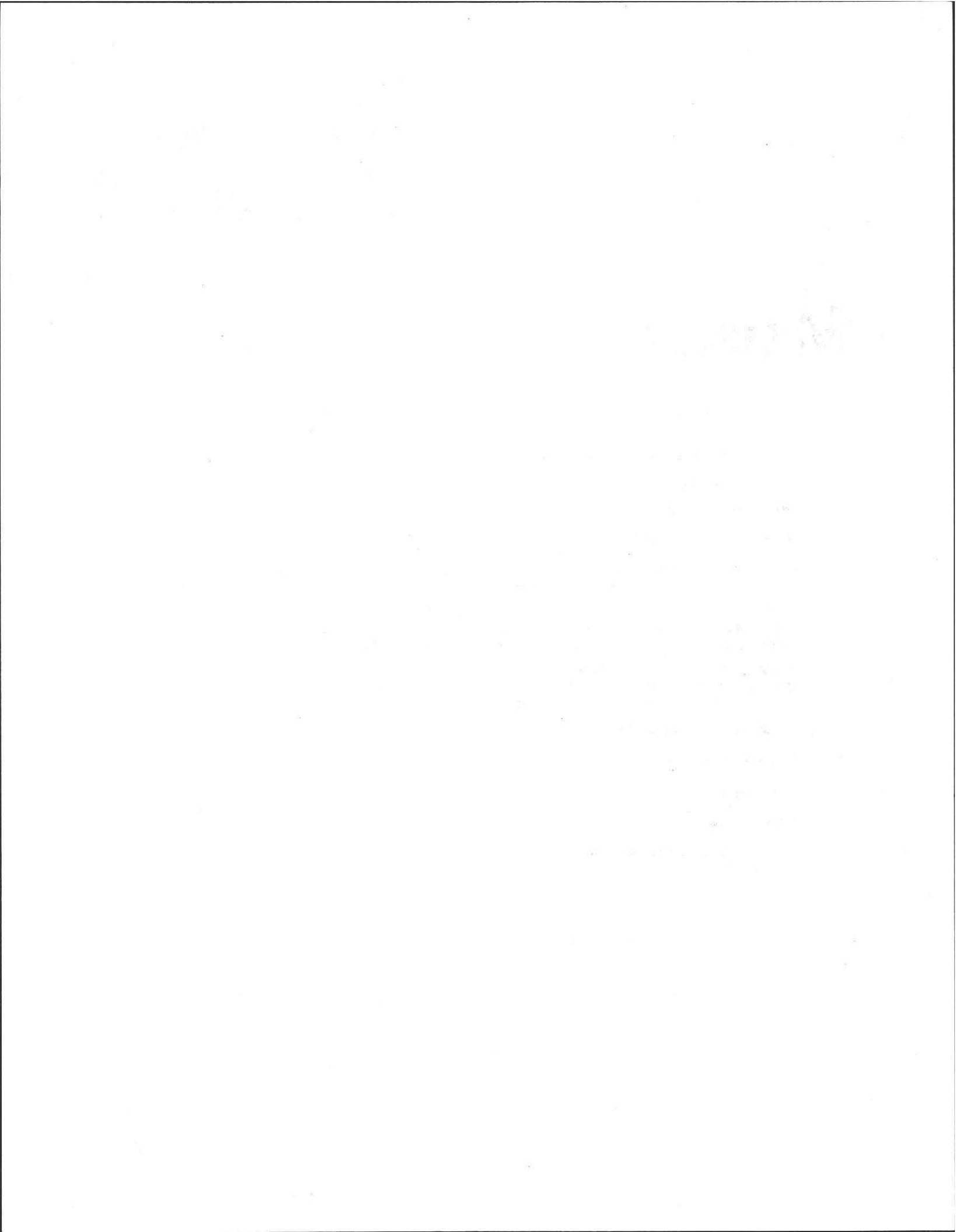
- 1) You as an agent may sign or have your client Sign All Copies of Permit and submit to the Local Health Department with the proper additional fees (\$??) permits. Please let me know when you are ready to send your check and permits to the Health Department at Town hall.
- 2) While you may get estimates during this review period, be certain that the contractor, that you hire must pick up the APPROVED PERMIT from the Health Department I have also enclosed a copy for you. The Bd. Of Health will also return a copy to you upon their approval.

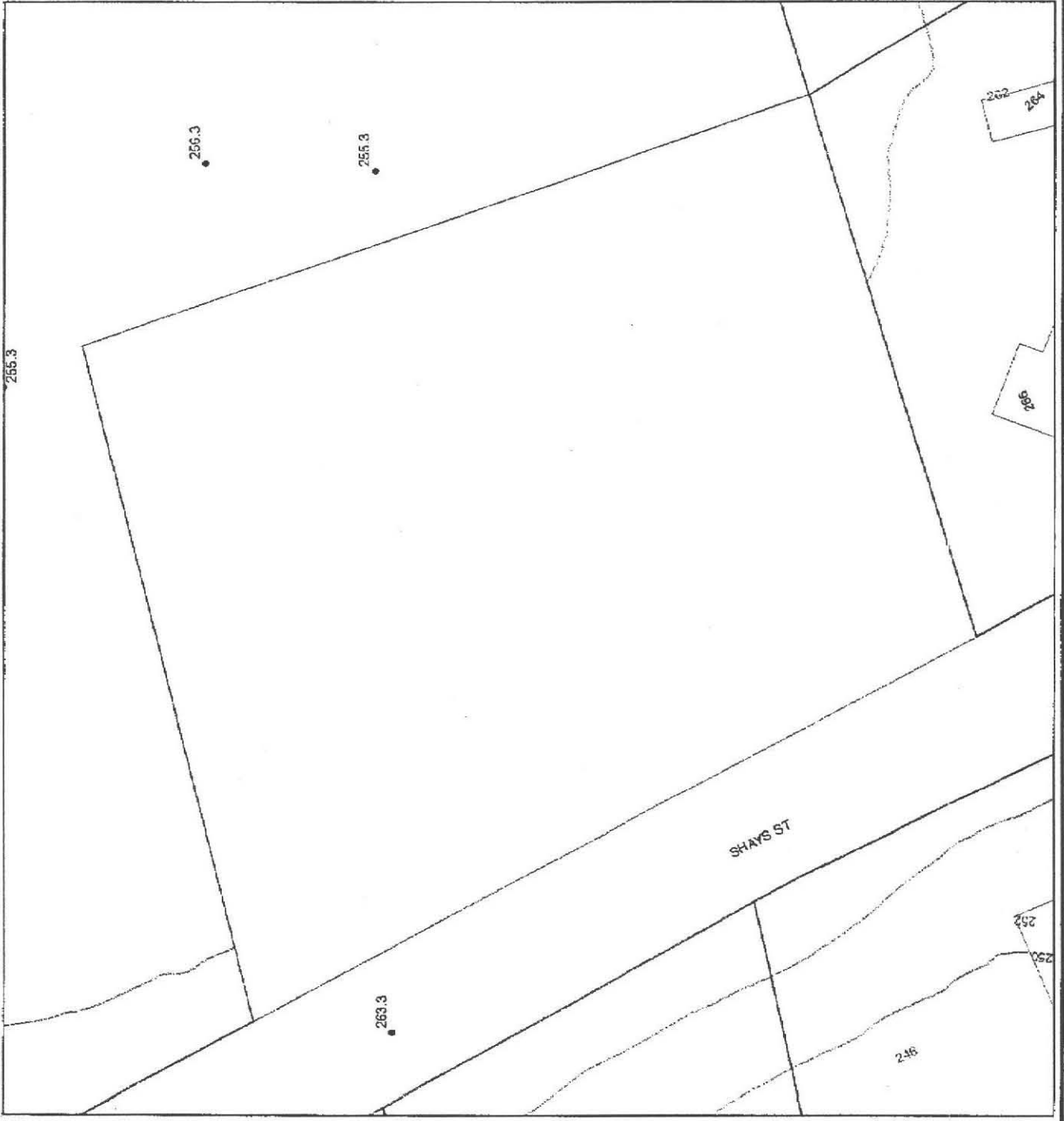

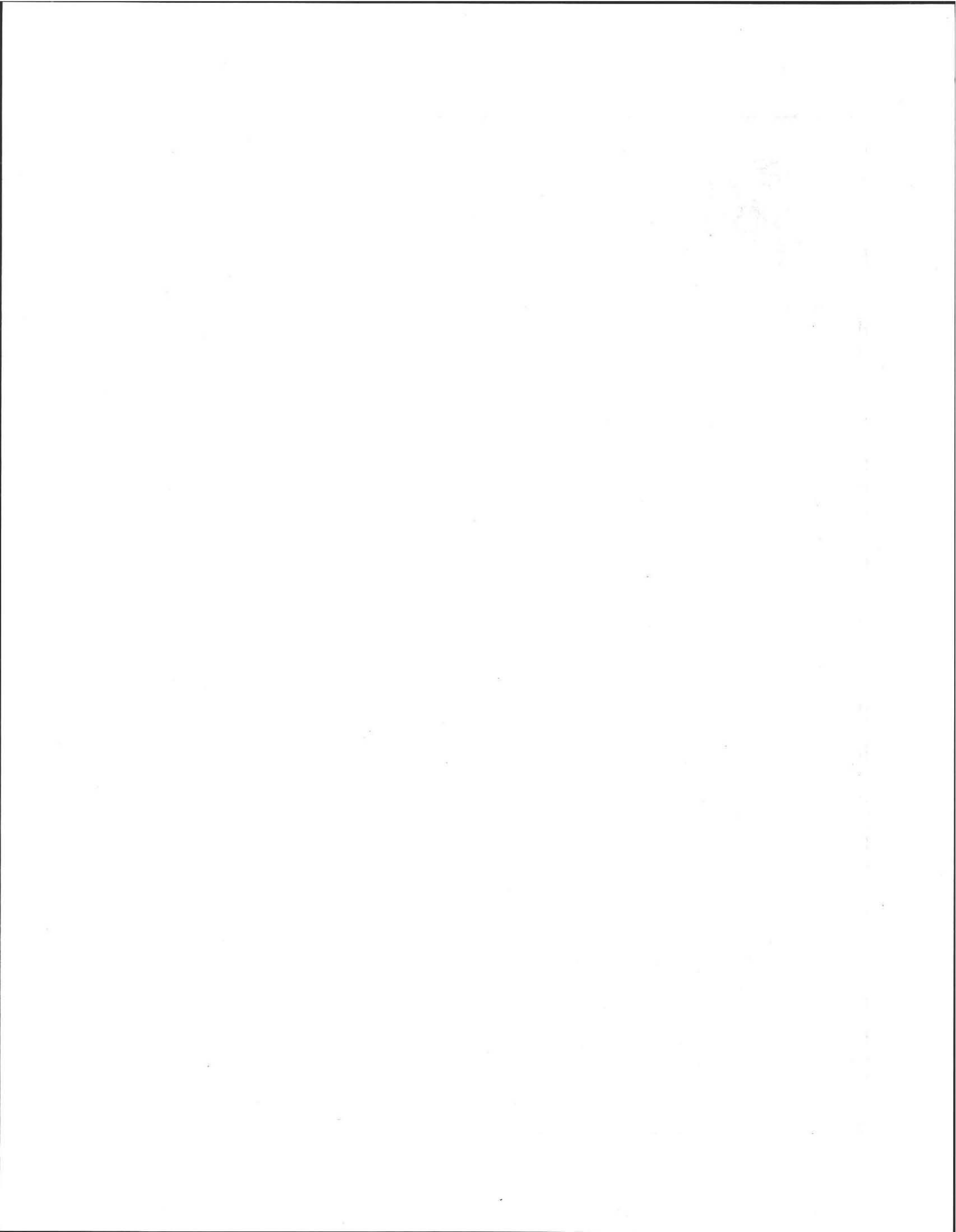
