

I'm fine with digging four holes, but I need to know exactly where they should be, and I gave you our map of the system, so we may need to coordinate on that. Are you finished looking at the paperwork? If so, can you send it back and indicate where we need to dig?

Please let me know when you expect to come to the house with the Town Inspector, so we can make sure to have the holes dug by then.
